Confidence is the reason Cummins is substantially increasing and in some cases doubling the base warranty coverage in hours of usage for many of our marine engines, ranging in size from the QSB6.7 up to our QSK95 engine.

Intermittent-Duty.

Cummins marine engines from 19 liters to 60 liters with intermittent ratings are now covered by a new base warranty that doubles the hours of coverage from 1,500 hours to 3,000 hours. Intermittent ratings are for applications that operate at or below full power for an average of two out of every eight hours.

Medium Continuous-Duty.

Engines 19 liters to 60 liters with a medium continuous-duty ratings will now have base warranty coverage for 1 year/4,000 hours. Medium Continuous ratings are for applications operating at or below full power for an average of six out of every 12 hours with an annual usage between 2,500 and 4,000 hours, depending on engine family.

Heavy-Duty.

The base warranty for QSB, QSC and QSL heavy-duty engine ratings has been extended to 2 years/6,000 hours while engines from 19 liters to 60 liters get 1 year/6,000 hour coverage. Heavy-duty engine ratings are for applications that operate at or below full power for an average of eight out of 10 hours with an annual usage between 3,000 and 6,000 hours, depending on engine family.

Continuous-Duty.

Even Cummins QSB, QSC, QSL and QSM engines used at full power in continuous, uninterrupted service are getting a warranty extension. Those engines now are fully covered for an unlimited number of hours during the first two years of operation.
